2. Dr. Vithalrao Vikhe Patil College of Engineering, Vilad Ghat, Ahmednagar

– (Henceforth referred to as **Party 2**).


Following Memorandum of Understanding has been reached between and signed by the above-mentioned two parties.

1. Party 1 will extend its support and sponsorship for the Projects (if available) and Practical's (if facility is available) for the undergraduate and post graduate students of Party 2, identified and approved by mutual convenience.
