Maharashtra State Power Generation Company (Mahagenco) is planning to deploy 660 MW super-critical units at the same location just like the current plant. This project will be stationed adjacent to the existing stage-I plant (2 x 140 MW) site at village Eklahare. Land requirement for the proposed project is about 36.6 hectares. The coal sources will be from Mahanadi coal blocks by MahaGuj Collierie s. The total cost of the project is around Rs 4,390 crore, 20% contribution will be by the State Government amounting to Rs 878 crore. The remaining funds will be supported from several lending institutions.


