Out of which stage-I units are out of service due to ageing .stage-II and stage-III are running as per the demand .main fuel of generating electricity is methane gas CH4 which is supplied from ONGC refinery uran through gas pipelines. After that the gas is processed with supplement of filtered air and it is fed towards gas turbine. Turbine is coupled to alternator .as the turbine rotates the alternator also turn to rotate. Generation is then connected to grid for feeding power. Gas turbine power station ,uran is asia's only one power plant that generates electricity from gas.
