
CLAUSE 1 CO-OPERATION


CLAUSE 2 SCOPE OF THE MoU





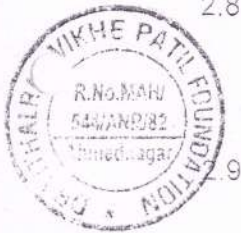

CLAUSE 4 VALIDITY



CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

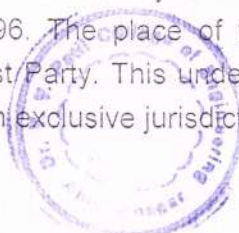
