### **Binding Character of this MEMORANDUM OF UNDERSTANDING**

Trainers shall pass on maximum discount for college batch and training fees shall be given in fees structure as per the workshop

#### Essential Terms of MOU:

- RES is responsible for conducting all the training programs
- RES will be responsible for providing training kits, tools, and other training related experimentalequipment.
- DVVPCOE will be At the training stationary equipment's such as Projector, White boards and Markers
- RES will provide certificate to participants as well as faculties those are attend the course
- RES will provide internship to the selected students near to the location where our site is running
- College will deduct TDS as per government noms and will provide required certificate to the RES
- DVVPCOE will bear the Electricity charges, Water charges used during the training program

#### Fees Structure

Rent will be transferred to DVVPCOE on monthly basis at the end of every month.

- RES will be responsible for the procurement and installation of 1.2 Kw ground

The MOU is effective from February 2019 for a period of 2 years


#### Confidential
