- USL will be responsible for providing training kits, tools, and other training related experimental equipment.
- DVVPCOE will bear the training stationary equipment's such as Projector, White boards and Markers.
- USL will provide certificate to participants as well as faculties those are attend the course
- USL will provide internship to the selected students near to the location where our project is running
- College will deduct TDS as per government noms and will provide required certificate to the USL.
