Dear Sir/Madam,

This is with reference to NBA's letter of even number dated 21-09-2012 in which status of accreditation applied by Padmashri Dr. Vithalrao Vikhe Patil College of Engineering, Ahmednagar, M.S. for five programmes has been conveyed including the date from which the period of accreditation is valid, based on the decision taken by the Executive Committee of National Board of Accreditation in its meeting held on 28<sup>th</sup> August 2012 that the duration of accreditation will be academic year-wise. The Executive Committee has subsequently decided that the above decision may be made applicable in respect of the applications of accreditation received in NBA on or after September 11, 2012 i.e. the date of issuance of minutes of the Executive Committee meeting held on 28<sup>th</sup> August 2012. In case of all applications received prior to September 11, 2012, the validity of period of accreditation may be conveyed from the date of approval by EC.

2. Accordingly, the period of validity of accreditation in respect of five programmes as conveyed under column 4 of para 2 of NBA's letter dated 21-09-2012 may be treated "w.e.f. 28-08-2012" instead of "w.e.f. 1<sup>st</sup> July, 2011".

3. All other provisions of the NBA's letter dated 21-09-2012 will remain unchanged.

This is with reference to application dated 21-12-2009 from Padmashri Dr. Vithalrao Vikhe Patil College of Engineering, Ahmednagar, M.S. seeking NBA accreditation of various programmes.

2. An Expert Committee conducted an on-site evaluation of the programmes on 25<sup>th</sup> to 27<sup>th</sup> November, 2011. The report submitted by the Expert Committee was considered by the Engineering Accreditation Evaluation Committee (EAEC) at its meeting held on 28-06-2012. The Executive Committee of the National Board of Accreditation considered the recommendations of EAEC at its meeting held on 28<sup>th</sup> August 2012. The Executive Committee approved the accreditation status of each programme of the Institute as given in the table below. The Executive Committee has also decided that the duration of accreditation will be academic year-wise. For this purpose the academic year will be considered from July to June. The period of accreditation in col. 4 below has been given accordingly.

Accreditation granted is provisional for 2 years. The Institution may apply after overcoming the weaknesses to upgrade their status to 'Full Accreditation' of the programmes.

\* Total falls short of aggregate after modification of Crit. VII as per guidelines.

The accreditation status awarded to the programmes as indicated in the above paragraph does not imply that the accreditation has been granted to Padmashri Dr. Vithalrao Vikhe Patil College of Engineering, Ahmednagar, M.S. as a whole. The complete name of the programmes accredited, level of programmes (UG or PG as the case may be) and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

4. The accreditation status of the above programmes is subject to change on periodic review, if needed, by the NBA. It is desired that the relevant information in respect of accredited programmes as indicated in the Table in paragraph 2 above, appears on the website and information bulletin of your Institution.

5. The accreditation status awarded to the programmes as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.

Copies of the Comprehensive Report submitted by the Chairman of the Expert Committee alongwith the detailed reports submitted by the Expert team for the programme (s) evaluated which visited your Institution are enclosed for reference and to take necessary action to improve upon the shortcomings, if any, pointed out by the Expert Team.

7. If the Institution is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
